### **Public Safety Committee**

#### For the energy networks

The Public Safety Committee (PSC) is one of the main subgroups of ENA's SHE Committee and its current objectives are to engage with regulators and stakeholders on key industry risks to promote and provide best practice advice to members of the public and third parties on the dangers associated with energy network assets and infrastructure.

ENA operate a range of Safety, Health, and Environment focused subcommittees reporting into the Electricity Network Industry Safety, Health, and Environment (SHE) Committee.

Our focus is on communicating up-to-date best practice advice with groups most at risk from gas and electricity networks infrastructure – both overhead and underground services – including DNO apparatus near or on commercial and consumers' premises, as well as supporting national campaigns and initiatives to raise awareness of the dangers from activities carried out in the vicinity of network assets.

From a publicity perspective, we develop a range of materials and roll out initiatives and campaigns to identify where national publicity might usefully be employed, as well as review and update previous Public Safety materials that ENA have produced for the sector.

Previous ENA PSC materials have consisted of videos, leaflets, publications, workshops and roadshows, alongside campaigns such as the Single Electricity Number 105 and disseminating the message appropriately. Examples of previous initiatives can be found on our website <a href="https://www.energynetworks.org">www.energynetworks.org</a>.

The ENA PSC are committed to formally engaging with Trade Associations outside the sector with members who have the potential to come into contact with electricity on a regular basis (Construction, Agriculture, Freight/Haulage Transport, among others).

The ENA Public Safety Committee also provides input into a number of industry wide groups and initiatives such as the National Farmers Unions (NFU), Farm Safety Partnership (FSP), the Utility Strikes Avoidance Group (USAG), Streetworks UK, Highway Authorities and Utilities Committee (HAUC(UK)), Civil Engineering Contractors Association (CECA) and more recently the Department for Energy Security & Net Zero's Electricity Storage Health and Safety Governance Group.



It was whilst at the Health and Safety Executive in his role as a Specialist Principal Inspector, he developed his passion for public safety from their activities close to network assets. Since 2010, Peter returned to industry in SHE leadership roles for UK Power Networks and more recently SSE. Peter is currently Head of SHE for SSE Networks Distribution. Peter also chairs the Electricity Networks Association's Public Safety Committee – a position he has held since 2011.

lan is a Chartered Electrical Engineer and Member of The Institution of Engineering & Technology.

lan's career in electrical engineering commenced with the manufacture, design and application of power system protection, control and instrumentation systems at GEC Measurements in Stafford. Ian then worked as a protection engineer and SAP on the transmission system for National Grid. Whilst at National Grid Ian became a protection system design engineer and commissioning engineer for major project work.

lan then joined the Health and Safety Executive as HM Specialist Inspector and has been HM Principal Specialist Inspector for over 20 years. Ian was HSE's team leader for its electrical engineering resource for 14 years and is now Technical Strategy Lead for electricity networks, public safety and renewable energy.

The Fall, Jason openly talks about his workplace accident and the effect this had on himself, family, friends and work colleagues but he know also explores and discusses why he made that decision on the day of his accident and how his own health and wellbeing in the months that led up to his accident also played a big part in that safety decision.

**The Bounce**, this part of the talk covers Jason's recovery from his mental health crisis. He talks about how some simple changes he made in his day to day life has had a positive impact on his wellbeing and then he discovered the resilience to start thriving in all aspects of his life, after just coping with anxiety, stress and mental health issues for nearly a quarter of a century.

Professor Tim Marsh, then at UMIST, was one of the team leaders of the original UK research into behavioural safety (in construction) in the early 1990s, is one of only a few Chartered Psychologists who are also Chartered Fellows of IOSH. He is considered a world authority on the subject of behavioural safety, safety leadership and organisational culture, was awarded a "President's Commendation" in 2008 by the International Institute of Risk and Safety Management and was selected to be their first ever 'Specialist Fellow' in 2010. The British Occupational Hygiene Society asked him to give the key note opening 'Warner Lecture' at their annual international conference in 2013. In 2014 he gave a key note to the Faculty of Medicine and gave the closing key note at the inaugural Campbell Institute 'International thought leaders' conference. He gave the opening key note address at Safeguard New Zealand (May 16) and was key note at the inaugural NEBOSH Alumni event.

Made visiting professor at Plymouth University in 2015. Formed Anker & Marsh with Jason Anker in 2018. Chair, Safer Highways 2017-19.

Founder of Ryder Marsh Safety he has worked with more than 400 major organisations around the world, including many international oil and gas, utility, chemical, transport and manufacturing organisations as well as the European Space Agency, the BBC, the National Theatre and Sky. Many clients have won both open and in-house awards. He has presented to the European Conference Board and was an expert witness at the "Safety Culture" and "Management of Change" expert forums at the Cullen Inquiry (Ladbroke Grove). As a continuation of the UMIST/HSE research he founded and ran Europe's largest behavioural safety event for fifteen years from 1997 until 2012 (when it was handed over to LexisNexis via RoSPA).



Richard Broome BSc (Hons) MRICS FAAV Managing Director LSBUD (LinesearchbeforeUdig)

Richard is a highly driven and motivated individual committed to developing the safety and efficiency of the UK utility industry. His work includes learning from international best practice and efficiencies, specialising in technological mapping solutions.

He is the Managing Director of the LSBUD (LinesearchbeforeUdig) service in Great Britain helping protect over 130 asset owners' networks by managing over 3.75 million third party enquiries per annum.

Richard is a fully qualified Chartered Surveyor, with experience across a variety of utility and property projects. Previous awards include the Pipeline Industries Guild Sir John Parker Presentation Competition and the National Joint Utilities Group Award for Avoiding Damage to Underground Assets. He leads the Data & Reporting Group of the Utility Strike Avoidance Group, producing the annual Utility Strike Report and increasing awareness of utility strikes across the UK.





She combines the skills learned as a lawyer, with the strong voice she discovered as part of campaign and support group Families Against Corporate Killers, to seek to ensure workers are able to head home safe to their loved ones at the end of each and every working day or night.

Louise is also a trustee of health and safety charity Scottish Hazards. She supports other bereaved family members as they navigate the investigation and prosecution processes. And works to secure long-term funding for the advice services Scottish Hazards provides to workers and communities.

Louise has been recognised across the SHE industry for her inspirational work, winning the SHP Award – Most Influential in 2018 and receiving the REHIS Meritorious Endeavours Award 2019. She is also a valued NEBOSH Ambassador, promoting NEBOSH initiatives and charitable work, including the Michael Adamson NEBOSH Diploma Scholarship offered since 2021 in honour of her brother, and being one of the first two recipients of a NEBOSH Honorary Diploma in 2023.


