# WS1A - Product 1 Common Evaluation Methodology and Tool

## Looking back...

- In 2020 Workstream 1A (Flexibility Services) Product 1 set out to deliver a common evaluation methodology and tool for DNOs to assess flexible vs non-flexible options to meet network needs
- Baringa was commissioned to deliver the common evaluation methodology and tool
- Baringa and Product team developed a proposed methodology
- Proposed methodology was extensively consulted on with engagements with Open Networks' Advisory Group, Ofgem and in Flexibility Consultation in summer 2020
- On 31 December 2020 the baseline Common Evaluation Methodology and Tool were published on the [ENA Open Networks website](#), along with User Guide, a number of Use Cases and a 'How to use video'

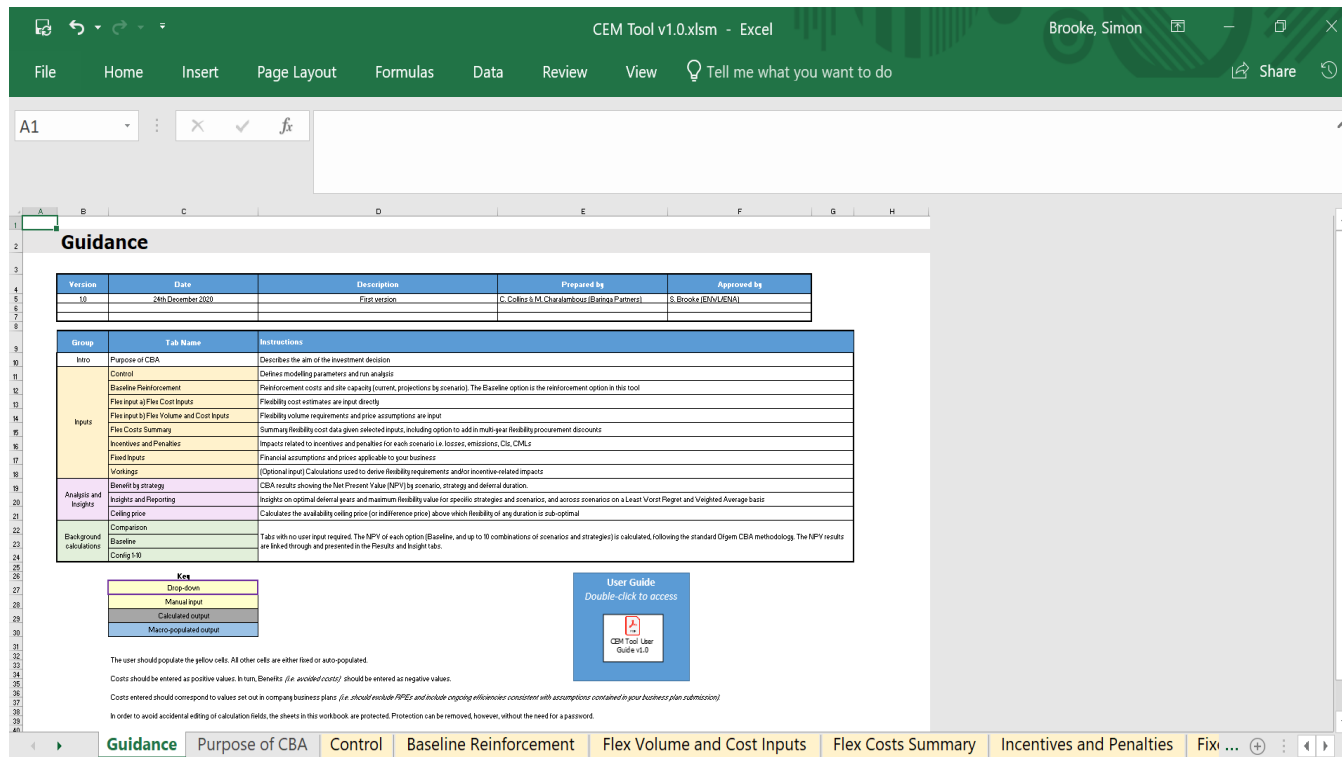
### Scope

- a) Review existing DNO approaches to choosing between ANM vs Flexibility vs Reinforcement to understand pros/cons.
- b) Develop common decision making methodology for DNOs, taking and reflecting input from stakeholders.
- c) Develop a common flexibility valuation analysis methodology by:
  - Gathering and assessing current practice (both in GB and internationally) for valuing flexibility
  - Considering current practice and propose common valuation methodology for flexibility
  - Developing a common valuation methodology (including a common tool)
  - Confirming future governance

(Note, this Flexibility valuation work is planned to align methodology and process and not the values themselves.)

# What is the Common Evaluation Methodology and Tool?

- A common methodology for DNOs to assess flexible vs non-flexible options to meet network needs
- Created primarily to evaluate deferring traditional reinforcement by purchasing flexibility the tool can be used to evaluate a range of non-flexible options eg energy efficiency and Active Network Management solutions
- The CEM Tool is an Microsoft Excel model based upon the Ofgem ED1 CBA



- DNOs use the tool to evaluate the costs and benefits of the selected options
- Tool allows the user to test different flexibility strategies under different load scenarios eg DFES, FES etc
- Provides insights to enable the user to make the decision under uncertain load scenarios



## Looking forward...

ENA standardises approach to flexibility for GB distribution network operators

- In 2021 we will put the Common Evaluation Methodology and Tool under open governance within Open Networks Project and set up a User Forum for the ongoing development of the methodology and tool
- In March 2021 we shared with the Advisory Group an outline of the open governance arrangements
- From 1 April 2021 all DNOs will use the new Common Evaluation Methodology Tool to evaluate flexibility – see full press release [here](#).
- In May 2021 we will share the Terms of Reference for the User Forum with Advisory Group and seek feedback; seeking nominations for the User Forum in mid to late spring 2021
- In July 2021 we hold the first User Forum and agree the development work for the methodology and tool for 2021

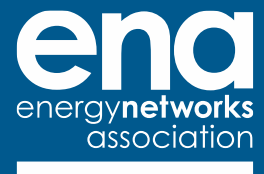
